Waste levy waiver for residual waste from donations - Charitable recycler

This form is to be completed by the charity producing residual waste from donations requiring disposal.

This form is to establish that a charitable recycler meets the necessary requirements for its waste to be subject to a partial waiver of the solid waste levy upon disposal under section 116 of the *Environment Protection Act 1993*.

The partial levy waiver applies to the following waste:

Waste resulting from donations to a charity, which cannot practicably be re-used, recycled or sold, and is being disposed of by or on behalf of that charity, provided that the charity:

- operates on a not-for-profit basis and with no commercial interest
- holds a licence under section 6 of the Collections for Charitable Purposes Act 1939
- is a deductable gift recipient for the purposes of laws administered by the Australian Taxation Office
- has appropriate measures in place to discourage scavenging and dumping of waste, and
- provides any other necessary information to the Environment Protection Authority as requested for the purposes of administering this waiver.
